IBPS PO/MT Eligibility Details: Institute of Banking Personnel Selection – IBPS conducts Common Written Examination (CWE) for the recruitment of Probationary Officers/Management Trainees posts that has been approved by each of the 19 participating public sector banks and managing committee of the Indian banks association (IBA). The Common Written Examination (CWE) for Probationary Officers/Management Trainees posts will be conducted twice a year by Institute of Banking Personnel Selection.

Eligibility Criteria:

Nationality/Citizenship: A Citizen of India.

Age limit: The minimum age limit is 20 years and maximum 30 years of age to general category candidates.

Educational qualification: Degree in any discipline from a recognized university or any equivalent qualification recognized as such by the Central Government.

IBPS PO/MT Selection Procedure: A Common Written Examination (CWE) will be conducted by the Institute of Banking Personnel Selection (IBPS) for selection of Probationary

Officer/Management Trainee posts in the 19 Public Sector Banks. It is a unique opportunity for candidates for a career in 19 Public Sector Banks through Common Written Examination. The Common Written Examination (CWE) for Probationary Officer/Management Trainee posts will be conducted twice in a year by Institute of Banking Personnel Selection (IBPS).

1. Eligible candidates have to apply through online application mode from the IBPS website.
2. Common Written Examination consists of two parts, one is objective type and second one is Descriptive paper total no. of questions is 250 and total marks 250, duration of 150 minutes for objective type questions and 60 minutes for Descriptive paper. The Descriptive papers of any those candidates who secure minimum qualifying marks in each of the objective tests will be evaluated.
3. After Common Written Examination, the Institute of Banking Personnel Selection (IBPS) will give scorecards for qualifying candidates in CWE. The scorecards issued by IBPS will be valid for one year from the date of issue of the scorecards.
4. When the 19 Public Sector Banks gave their own Individual advertisement and determine eligibility details to apply for recruitment of particular Bank.
5. Based on scorecard the eligible candidates may apply for particular Bank advertisement and attend for interview with in one year issued of the scorecard. Each Bank will then individually short list candidates and carry out their own selection procedure.

IBPS PO/MT Exam Pattern Details: Institute of Banking Personnel Selection – IBPS conducting Common Written Examination (CWE) for Probationary Officers (PO) / Management Trainees for 19 national banks twice in a year. IBPS Common written examination exam pattern details given below...

Common Written Examination consists of two parts, one is objective type and second one is Descriptive paper total no. of questions is 250 and total marks 250, duration of 150 minutes for objective type questions and 60 minutes for Descriptive paper. There will be Negative Marking of 0.25 marks for each wrong answer in objective type Exam. IBPS CWE Scorecards will be sent to the qualified candidates by Speed Post/Register Post. IBPS CWE Scorecard has validity of 1 year from the date of issuing. Candidates can apply to the Bank notifications with the Scorecard.

Educational Qualification:

(i) For I.T. Officer (Scale I & II): Any Degree from a recognized University having passed DOEACC 'B' level.

(ii) For Agricultural Field Officer (Scale I): Degree in Agriculture or allied specializations from Recognized University.

(iii) For Rajbhasha Adhikari (Scale I): A PG Degree in Hindi with English as a subject at the degree level OR a PG degree in Sanskrit with English and Hindi as subjects at the degree level.

(iv) For Law Officer (Scale I & II): A Bachelor Degree in Law (LLB).

(v) For Technical Officer (Scale I): Degree in Engineering.

(vi) For HR/Personnel Officer (Scale I): Any Degree from a recognized university and PG degree or diploma recognized by AICTE in Personnel Management / Industrial Relations/ HRD/Social Work / Labour Law from a recognized University.

(vii) For Marketing Officer (Scale I): MBA (Marketing) / 2 years PGDBA / PGDBM or any other equivalent degree or diploma with specialization in Marketing from a recognized University/ Institution

Specialist officers will be conducted twice a year by Institute of Banking Personnel Selection. The following are the Exam Pattern Details...

Exam Pattern: Selection will be made on Written Examination. The structure of the Written Examination may be conducted either in online/offline & is as follows...

1. All the Tests will be in Objective Type & is printed in Bilingual Format, except for English Paper.

2. The Specialist Officers Common Written Examination consists of 200 Objective Type Questions, each question carries one mark totally 200 marks and the time duration is 120 minutes.

5. Negative Marking: There will be a negative marking of 0.25 mark for each wrong answer in objective type Exam. If for any question a candidate gives more than one answer, it will be treated as wrong Answer.

6. Cutoff Score: Each candidate will have to secure a minimum standardized score in each of the tests to qualify in the written examination and to be considered for vacancies in the participating banks. The cut-off points will be decided based on the average.

7. CWE Score Card: IBPS will print the Score Cards for each of the qualifying candidates only and will send the same by Registered/ Speed post to each candidate at the correspondence address specified in his/ her online application.

8. Validity of Score Card: Score Cards issued by IBPS will be valid for one year from the date of issue of the Score Card.

Educational qualification:

1. Degree in any discipline from a recognized University or any equivalent qualification recognized as such by the Central Government.
2. Computer literacy: Operating and working knowledge in computer systems is mandatory.
3. Proficiency in the Official Language of the State/UT for which vacancies a candidate wishes to apply is preferable.

The Common Written Examination (CWE) for Clerical Cadre posts will be conducted once in a year by Institute of Banking Personnel Selection. Common Written Examination for recruitment of Clerks has been accepted by each of the 20 participating Public Sector Banks and the Managing Committee of the Indian Banks' Association (IBA) with the consent of the Government of India.

1. Qualified candidates have to apply through online application mode from the IBPS website.
2. Institute of Banking Personnel Selection (IBPS) conducts this Online Exam for Clerical Cadre posts. Total no of questions is 200, total marks 200 and total time duration of 2 hours for objective types questions. There will be Negative Marking of 0.25 marks for each wrong answer in the objective type exam.
3. The candidates who qualified in the online test, they are considered for the vacancies of the participating banks, the cut-off will be decided based on the average 1/4 Standard Deviation for general candidates and 3/4 Standard Deviation for reserved category candidates.
4. Candidates who qualify in CWE Clerk-II, will subsequently be called for a Common Interview to be co-ordinated by IBPS. Candidates, successful in qualifying in both the CWE and Common Interview will be listed in the order of merit. Depending on the vacancies in each bank of his preference, candidate will receive through a computerised system an offer from any one of the Participating Public Sector Ban
